

# **ASO** Function

- 1. Global policy development process
- 2. Provide recommendations to the Board of ICANN concerning the recognition of new RIRs
- 3. Define procedures for selection of individuals to serve on other ICANN bodies, in particular on the ICANN Board
- 4. Advise the Board of ICANN on number resource allocation policy, in conjunction with the RIRs
- 5. Develop procedures for conducting business in support of their responsibilities

#### ASO Function Global policy development process

- Policy for allocation of IPv4 blocks to RIRs
  - 3 September 2004 Policy forwarded to ICANN Board of Direcors
  - 8 April 2005 ICANN Board of Directors resolution
  - Policy for allocation of IPv6 blocks to RIRs

- Introduction of new gTLDs
- IPv6
- DNSSEC
- enum
- Internet security (from both a user and a government perspective)
- Actions by governments
- WSIS, WGIG
- Increasing importance of participation by the global community in the policy development of the DNS
- The future of the MOU or other contractual agreements with the US DOC

- Refered to the NRO EC
- Major issues identified by ASO AC:
  - IPv6
  - Independence from government
