You will receive a maximum of 2 iterations of the publication. **Please provide everything by Wednesday, 13 May 2020.** Please keep in mind that all materials, new or updated, need to be evergreen.

Translation-only Deadline

If your publication requires translation, **please provide the final material(s) by Monday, 25 May 2020.** This ensures that there is enough time to translate the publication by the below print deadline. If your materials require design assistance (outlined above), please note that the final materials will have to be complete, including the edit/approval process, by this deadline in order to be translated.
