NEW: Operational Design Phase: Updated Concept Paper

ICANN org has shared an updated version of the <u>Operational Design Phase Concept Paper</u>. The new version follows community consultation during ICANN69, including written feedback by a number of community groups. The community is asked to provide input by **Friday**, **22 January 2021**. ICANN org will also conduct a webinar; details will be shared shortly.

The concept paper proposes an Operational Design Phase (ODP) that is to become part of the policy and implementation life cycle. The ICANN organization will conduct the ODP for consensus policy recommendations that are approved by the Generic Names Supporting Organization (GNSO) Council. The purpose of the ODP is to provide the Board with relevant information to decide, as required by the Bylaws, whether a recommendation is in the best interest of the ICANN community or ICANN.

ICANN Supporting Organizations and Advisory Committees will be requested to provide up to two members from their respective group to help choose the recipient of the 2021 ICANN Community Excellence Award.

The 2021 ICANN Community Excellence Award will be presented during ICANN71. A community selection panel will be formed to review the nominations and select the award recipient.
