NEW: ICANN72 Board Workshop: DNS Abuse Informational Discussion

The ICANN Board of Directors holds a regular workshop prior to each ICANN meeting. For ICANN72 the Board workshop program will include a Board discussion with a panel of security professionals and experts, to enhance the Board's understanding of what constitutes DNS abuse and how various organizations are approaching its mitigation. This session will be held on **Friday 22 October, from 16:00**- 19:30 UTC. It will be open to the community to attend, although, as is customary with other open Board sessions, attendees will not be able to interact directly with the speakers.
