However, depending on what you mean by DNS abuse, some types may not fall within ICANN's responsibility as the technical coordinator of the DNS. ICANN is not the Internet's content police. Instead, ICANN org has a program focused on DNS security threats, which adhere to ICANN's technical role and capabilities.
