The ICANN75 Prep Week schedule is [now available](#). It consists of eight sessions to prepare the ICANN community for the ICANN75 Annual General Meeting taking place 17-22 September 2022.

REMINDER: ICANN Continues the Pandemic Internet Access Reimbursement Program

ICANN announced the continuation of the Pandemic Internet Access Reimbursement Program for ICANN75. The hybrid [ICANN75 Annual General Meeting](#) is being held **17–22 September 2022**. The deadline for reimbursement program applications is **2 September 2022**.

Interested ICANN community members must apply in advance of ICANN75, and those who meet the eligibility requirements will be selected to participate. The application process opens **Monday, 08 August 2022**. The application deadline is **Friday, 02 September 2022 at 23:59 UTC**.

The goal of this program is to facilitate participation in ICANN Public Meetings during the pandemic. It offers community members who have limited Internet capacity financial assistance to increase their Internet bandwidth.

Since ICANN75 will be conducted as a hybrid meeting, only applicants that attend virtually are eligible for

this program.

In 2019, the ICANN Board initiated a project aimed at enhancing the effectiveness of ICANN's multistakeholder model – one of the strategic objectives outlined in ICANN's Strategic Plan for Fiscal Years (FY) 2021-2025. This effort is critical to ensuring that the multistakeholder model evolves and meets the changing needs of the ICANN community.

The Implementation Operations team is offering an up to 30 minute interactive update on this project, more specifically on the evaluation methodology, which is used to assess the current projects/initiatives that are supporting the multistakeholder model.

NEW: Share Your Feedback on the Registration Data Policy Implementation Plan

Today, ICANN Org opened a Public Comment proceeding on a proposed [Registration Data Policy Implementation Plan](#). This plan is the result of three years of work and collaboration including ICANN Org's Policy Implementation Project Team (IPT) and the Community's Implementation Review Team (IRT). The implementation plan includes a draft policy and proposed updates to 20 existing consensus policies and procedures impacted by the Community's recommendations concerning generic top-level domain (gTLD) registration data. The opening of this Public Comment is a tremendous achievement and a true testament to the multistakeholder model at work.

Implementation of Work Stream 2 (WS2) of the Cross Community Working Group on Enhancing ICANN Accountability (CCWG-ACCT) continues to be a priority for the ICANN organization (org) in Fiscal Year 23.

Work continues on the 95 accountability and transparency-related [recommendations](#) directed at ICANN org, the Board, and the community. The ICANN org continues to support community groups' implementation work, as appropriate, and discussions of the WS2 Community Coordination Group (WS2 CCG), as it coordinates work on a set of recommendations that warrant a uniform community-wide approach. CLOSES TODAY: A Request for Planning Prioritization Group FY24 Nominations

The updated Planning Prioritization Framework (Version 2) has been published on the ICANN Finance and Planning Community wiki workspace here ([Planning Prioritization Framework V2](#)). We would like to hold meetings with the community-based Planning Prioritization Group in September and early October 2022. This timing will permit ICANN org to receive input for the development of the Draft Operating Plan and Budget which is scheduled for Public Comment in December 2022. The prioritization process is a step in the annual ICANN planning process.

The scope of activities to be included in this prioritization process are Board-approved implementation work such as PDP recommendations, Specific Review recommendations and the implementation of other non-policy and advice work.

As the FY24 Planning Prioritization Group will comprise members from the same community groups that participated in the pilot, we ask that the relevant groups please either re-confirm that the member(s) from your group are available to continue their participation. The Internet Corporation for Assigned Names and Numbers (ICANN) organization is soliciting proposals to identify a provider to conduct service organization control audits. These audits represent an important component of the accountability ICANN has to Internet stakeholders for the proper performance of the Internet Assigned Numbers Authority ("IANA") functions. The audits are mandated by the various contracts between ICANN and the Internet Engineering Task Force (IETF), the Regional Internet Registries (RIR) and Public Technical Identifiers (PTI).

Indications of interest should be emailed to PTI.SOC2.SOC3.Audits-RFP@icann.org. Proposals should be electronically submitted using ICANN's sourcing tool by 23:59 UTC on 20 September 2022. Access to this tool may be requested via the same email.
