Please keep in mind that all materials, new or updated, need to be evergreen.

### 13 SEPTEMBER 2023 TRANSLATION DEADLINE:

If your publication requires translation, please provide the final material(s) to [Andrea Glandon](#) by **13 SEPTEMBER**. This ensures that there is enough time to translate the publication by the start of the meeting, with the possibility of potential changes. If your materials require design assistance (outlined above), please note that the final materials will have to be complete, including the edit/approval process, by this deadline to be translated
