





Regional Registry Turnaround Time (October – December 2017)





Global Formal Notice Trends (October – December 2017)






Registrar Complaint Volume and Turnaround Time (TAT)








Registrar Complaint Types and Top Closure Reasons (October – December 2017)















Registry Complaint Types and Top Closure Reasons (October – December 2017)
