EXECUTIVE SUMMARY:

Over the past several months, the NGPC has taken several actions to respond to the

advice in the GAC's Beijing and Durban Communiqués, including:

adopting a Scorecard of 1As on 4 June 2013 in response to non-safeguard advice

in the Beijing Communiqué;

adopting a resolution on 25 June 2013 on the safeguards applicable to all strings,

and Category 2 Exclusive Registry Access; and

proposing a way forward to address the GAC's Category 1 Safeguard Advice in

the Beijing Communiqué.

PROPOSED ACTION: For Discussion

EXECUTIVE SUMMARY:

In the Beijing Communiqué, the GAC proposed "Category 1" safeguard advice, which includes recommended restrictions and consumer protections for sensitive strings and regulated markets. The Category 1 Safeguard Advice is identified in the GAC Register of Advice as "2013-04-11-Safeguards-Category-1".

At its 2 July 2013 meeting, the NGPC adopted a resolution to defer entering into registry agreements with applicants who have applied for TLD strings listed in the GAC's Category 1 Safeguard Advice, pending a dialogue with the GAC. As noted by the community during the public comment period on the GAC's safeguard advice, the GAC's Category 1 Safeguard Advice presents some implementation concerns.

The NGPC began a dialogue with the GAC during the ICANN 47 meeting in Durban, South Africa. After hearing the concerns of the GAC in Durban and discussing the implementation issues, the NGPC prepared a proposal to implement the advice, and transmitted the proposal to the GAC on 29 October 2013. The proposal transmitted to the GAC is included in the reference materials to this paper.

To implement the Category 1 Safeguard advice, the proposal transmitted to the GAC modifies the text of the Category 1 Safeguards as appropriate to meet the spirit and intent of the advice in a manner that allows the requirements to be implemented as public interest commitments in Specification 11 of the New gTLD Registry Agreement ("PIC Spec"). The proposal also distinguishes the list of TLD strings listed in the Category 1 safeguard advice between strings that the NGPC considers strings associated with market sectors or industries that have highly regulated entry requirements in multiple jurisdictions, and those that do not. The Category 1 Safeguards in the PIC Spec would apply to the TLD strings based on how the TLD string is categorized.

The proposal considers the input from the community received during the public

comment forum initiation on 23 April 2013 on how the NGPC should address GAC

advice regarding safeguards applicable to broad categories of New gTLD strings
