1. Procedural Evaluation of Reconsideration Request 21-3	The BAMC conducted a procedural evaluation of Reconsideration Request 21-3 in accordance with Article 4, Section 4.2(k) of the Bylaws. Request 21-3 was submitted by Dot Hip Hop, LLC (Requestor), challenging alleged ICANN staff inaction on a request for assignment of the .HIPHOP generic top-level domain (gTLD) from the current registry holder, UNR Co. (UNR), to the Requestor. Specifically, the Requestor alleged that ICANN staff's "failure to approve the assignment" violated the Registry Agreement between UNR and ICANN and ICANN org's Mission, Commitments, and Core Values."" The BAMC concluded that Request 21-3 was sufficiently stated and will continue to be processed under the reconsideration request process.	11 January 2022	The BAMC determined that Request 21-3 was sufficiently stated pursuant to Article 4, Section 4.2(k) of the ICANN Bylaws, however the Requestor withdrew Request 21- 3, effective 13 January 2022.

Reconsideration Request 22-1	reconsideration of alleged ICANN Board and staff action and inaction regarding the redaction of certain information from <u>Resolutions 2022.01.16.01 – 2022.2016.04</u> (Resolutions). The Resolutions approved contract renewals with two vendors to provide support services to augment ICANN E&IT capacity. The Requestor asserted that the redactions violate Article 3.1 of the ICANN Bylaws on openness and transparency and preclude the public from determining whether the requirements for the direct contracting selection process under Section 3.3 of the ICANN Procurement Guidelines were met. The Requestor explicitly stated, however, that he was not challenging the Board's underlying decision to approve the renewal of the		Reconsideration Request 22-1 (see <u>BAMC Summary Dismissal</u> ).
6. Consideration of Request for Urgent Consideration of Reconsideration Request 22-2	contracts.The BAMC considered whether Reconsideration Request 22-2qualifies for urgent treatment as requested by the Requestorspursuant to Article 4, Section 4.2(s) of the Bylaws. Request 22-2sought reconsideration of alleged ICANN staff action regarding atravel waiver that participants were required to accept to attendthe ICANN74 Public Meeting in person (ICANN74 In-PersonTravel Waiver or Waiver). The Requestors alleged that theWaiver is "unduly wide and harsh". The Requestors claimed thaturgent reconsideration was warranted because ICANN74 was tobe held on 13-16 June 2022 at The Hague and "[t]ravelarrangements must be made, and the closer it gets to thedeadline the more difficult and expensive they become."The BAMC concluded that urgent consideration is available ofonly "Board action or inaction," not staff action or inaction. TheBAMC found that Request 22-2 does not qualify for urgenttreatment because the Requestors are not challenging a Boardaction or inaction. The BAMC noted that the Requestors werefree to file a new reconsideration request within "the regulartime frame" set forth in the Bylaws, and that in the interest of	14 April 2022	On 14 April 2022, the BAMC denied the Requestor's Request for Urgent Consideration of Request 22-2 (see <u>BAMC</u> <u>Determination</u> ).

Legal Invoices for Dispute Matters	The BAMC approved recommendations to the Board to approve a tranche of money for payment of legal invoices and fees relate to certain dispute matters.	18 May 2022	On 26 May 2022, the Board approved a tranche of money to pay existing and upcoming outside legal fees and Independent Review Process (IRP) Panel fees for two IRP matters (see <u>Resolutions 2022.05.26.02 –</u> <u>2022.05.26.05</u> ).
8. Procedural Evaluation of Reconsideration Request 22-2	The BAMC conducted a procedural evaluation of Reconsideration Request 22-2 which challenges the ICANN 74 In Person Participation and Travel Waiver as "unduly wide and harsh" because, among other things, it "constitutes a blanket exclusion of liability," grants ICANN employees, agents, and representatives discretion to require a participant to leave the event, and requires foreign nationals to review a U.S. website (the U.S. Centers for Disease Control and Prevention website) for health travel advisories. The BAMC determined that Request 22- 2 was not sufficiently stated and therefore did not satisfy the procedural evaluation because the Requestors did not satisfy the requirements to maintain a Reconsideration Request under Article 4, Section 4.2(c) of the ICANN Bylaws.	1 June 2022	On 1 June 2022, the BAMC summarily dismissed the Reconsideration Request 22-2 (see <u>BAMC Summary Dismissal</u> ).
