It is anticipated the OEC will make a recommendation to the Board to adopt the revised NPOC Charter in February 2023.</li> <li>● The GNSO Charter Amendments process was revised by the community and as with the NPOC, was reviewed by the OEC before proceeding to Public Comment. It is anticipated the OEC will make a related recommendation to the Board in February 2023.</li> <li>● The Internet Service Providers and Connectivity Providers Constituency (ISPCP) of the GNSO is anticipated to revise their Charter in Q2 2023.</li> </ul>
