The supplementary materials that I make available here (a complete table of contents for each book, errata for each edition, and an additional section and exercise solutions for *Classical Fortran*) are derived works that *benefit* the copyright holders by *encouraging* potential buyers. I do intend these supplementary materials to be for profit, but they meet the other fair use tests and I believe they do no injury to the copyright holders.
- For the course “Reading Classical Hebrew” I provide supplementary content of my own composition and an alphabetical index to all of the course materials. These addenda are used in conjunction with the required textbook *The First Hebrew Primer*, but I believe they are not sufficiently derivative of it to infringe its copyright. The file `supp.pdf` includes scans of a few representative pages from each of one dictionary, two siddurim, and two Chumashim, annotated to explain how to use those books, and I believe this meets the tests of fair use. In teaching the course on Zoom I display textbook pages so that I can point to words as the students read from their own copies of the printed book. I believe that this classroom use of the book is also permitted by the Copyright Act, and that my use of Zoom is therefore in compliance with its Terms of Service.
- My book *Hannah Senesh Word by Word* is adapted from a Hebrew reader published by an organization that appears to be no longer in existence. To make my book I revised the original text, produced an English translation, and typeset the result in a format that facilitates learning the Hebrew vocabulary. My diligent efforts to contact the most likely successor organization having failed, I assume that the 1952 copyright on this work no longer has an owner.

- My textbook *Introduction to Mathematical Programming*, which is released under a Creative Commons license by way of this website, refers to several software packages by their trademarked names (see the verso page of that book) and I believe that doing so is fair use.
- Assertions that I have fairly used ideas from software written by others are made in footnote 12 on page 52 of *Computing Fourier Transforms* and at the Reference citation on page 7 of the additional textbook section in `precise.pdf`.
- The Hebrew font files are freely downloadable from <https://ctan.org/pkg/redis> so I assume that they are in the public domain.
