The Subsequent Procedures Operational Design Phase (SubPro ODP) project team reviewed the 300+ outputs in the Final Report on the new gtld-Subsequent Procedures Policy Development Process and collaboratively drafted assumptions across all 41 topics of the Final Report. In 2019, ICANN org worked with the community to establish a set of planning assumptions for SubPro. The most recent version of these assumptions was published here in September of 2020. A Set of Assumptions was shared and presented for discussion during the ICANN73 SubPro ODP session. Since then, the project team has continued its work. This document presents a total of 84 assumptions by topic that have not been shared with the community and 239 assumptions by topic that have previously been shared with the community that are shaded gray. Previous versions of this document included assumption policy questions that are now located in a separate document here. Index numbers have been added to the assumptions document as a way to reference specific assumptions in future documents. A '.U' in the index number indicates a previously published assumption that has since been updated.
