Executive Summary of Unaudited Financial Results For the Three Months Ending 30 September 2017

Overview - ICANN Operations and New gTLD Program

The total ICANN change in net assets is \$4.3M higher than budget for the period mainly due to: (i) underspend in planned operations for ICANN Ops \$5.1M primarily due delayed activities across the organization and (ii) total ICANN investment gains of \$2.6M; partially offset by (iii) lower than budgeted funding for ICANN Operations (\$1.2M), (iv) lower revenue recognized for the New gTLD Program (-\$1.6M), (v) higher expenses due to auctions fees; offset by lower evaluation costs due to extension of the New gTLD Program (\$0.7M). See below.

The Funds Under Management by ICANN increased by \$1.1M during the period to a total of \$460.6M, mainly as a result of (i) net funds collected from contributors and contracted parties (\$33.2M); and (ii) Reserve Fund gains (\$2.6M), and (iii) New gTLD operating activities of (\$0.6M) partially offset by (iv) general operating expenses for ICANN Ops (-\$35.4M)

Financial Position

The Funds Under Management increased by \$1.1M during the period as a result of the following:

An increase of the ICANN Operations funds by \$4.7M due to:

- (i) funds collected from contributors/ parties of \$33.2M
- (ii) the reimbursement to ICANN Ops from the New gTLD Program for direct/allocated costs for \$4.4M and Historical Development Costs for \$0.6M, and
- (iii) the appreciation of investments for \$1.9M, partially offset by
- (iv) payments to vendors/ employees of \$35.4M, \$3.8M of which were on behalf of the New gTLD Program.

A decrease of the New gTLD funds by \$3.6M due to:

- (i) the reimbursement to ICANN Ops from the New gTLD Program for direct/allocated costs for \$4.4M and Historical Development Costs for \$0.6M, partially offset by
- (ii) lower operating expenses than planned for \$0.6M
- (iii) the appreciation of investments for \$0.8M,

Funding

Funding for ICANN Operations was \$1.2M lower than budget primarily due to: (i) lower than budget Transaction Fees (-\$1.1M) due to lower transactions volumes than budgeted, and other funding fees are lower than budget (-\$0.3M) due to timing for the contributions from cctlds and RIRs

Funding for New gTLD program was \$1.6M lower than budget primarily due to (i) the timing of evaluation activities resulting in lower than planned revenue recognized.

Operating Expenses

Personnel expenses for ICANN Operations were \$0.2M favorable to budget primarily due to: (i) lower average headcount than planned (399 vs 414) due to slower hiring and attrition.

'Personnel expenses for the New gTLD Program were \$0.1M favorable to budget due to: (i) lower allocation expenses from ICANN operations due to the extension of the New gTLD program.

Travel and Meetings expenses for ICANN Operations were flat to budget.

The New gTLD Program Travel and Meetings costs were flat to budget.

Professional Services expenses were below budget by \$3.6M primarily due to: (i) timing differences across various activities and projects including Language Services, Specific Reviews, GDD Operations, and Public Responsibility projects (+\$3.3M)

Professional Services costs for the New gTLD Program were \$0.9M higher than budget due to legal fees for pending and open rexonsideration processes.

Administration expenses were lower than budget by \$1.1M primarily due to: (i) timing of Office of the Chief Technology Officer sponsorship fees \$0.4M and (ii) unbudgeted transfer of data center expenses from Administration category to capital \$0.3M.

Administrative costs for the New gTLD Program were flat to budget.

Bad debt: On the basis of the historical trend of uncollectible receivables, the level of bad debt on reserve at the end of the period was sufficient and therefore no additional bad debt expenses were budgeted or reserved during the period.

Depreciation costs were flat to budget.

Other Income /Expense

Other income/ expense for ICANN Operations was \$1.9M favorable to budget due to realized gains of \$0.3M and unrealized gains of \$1.6M on investment accounts.

Other income/ expense for New gTLD was \$0.8M favorable to budget due to realized gains of \$0.7M and unrealized gains of \$0.1M on investment accounts



The variances from 30 June 2017 to 30 September 2017 are as follows:

New gTLD Auction Proceeds increased by \$0.4M due to: (i) the receipt of funds for the auctions held during the period (\$135.0M); and (ii) gains on the investment of funds (+\$0.5M), partially offset by auction fees (-\$2.9M).

New gTLD funds decreased by \$3.9M mainly due to: i) the repayment to ICANN Ops for Historical Development costs and accumulated direct allocated costs incurred on behalf of the program (-\$11.9M); and ii) net refunds to applicants and disbursements to vendors of (-\$3.2M), partially offset by the appreciation in the market value of investments (+\$0.7M).

The **ICANN Operations Operating Fund** increased by \$2.8M as a result of:(i) the net impact of cash received from contracted parties of (+33.2M), and (ii) the cash received from the New gTLD Program for repayment of Historical Development costs and accumulated direct allocated costs incurred on behalf of the program (+\$5.0M), partially offset by (iv) payments to employees and vendors of (-\$35.4M), \$4.4M of which was on behalf of the New gTLD Program.

The ICANN Operations Reserve Fund increased \$1.9M as a result of the appreciation in the market value of investments.
