









FY20 (Jul 19 – Dec 19) Operating & Capital Expenses






FY20 (Jul 19 – Dec 19) Operating & Capital Expense


FY20 (Jul 19 – Dec 19) New gTLD Program Expenses vs Budget

Lower refunds of withdrawn applications.


