Due to COVID-19 travel restrictions, five Board meetings/workshops which were planned to be face-to-face were held virtually and, as such, there were no travel or travel-related expense reimbursements paid directly to or on behalf of Board members for these meetings. These virtual meetings were held around the first two ICANN Public Meetings (October 2021 and March 2022) and three Board workshops (September 2021, January 2022, and April 2022). One face-to-face meeting took place during the ICANN Public Meeting in The Hague in June 2022. After approval, payments were made on behalf of Board members for other virtual meetings, trainings, and subscriptions.

Göran Marby serves as President and CEO and is a member of the Board. Pursuant to his employment agreement, in FY22 Mr. Marby was paid \$728,349 in salary, and \$217,709 for at-risk pay, along with \$52,407 in reimbursement of expenses, and \$57,631 in payments were made on his behalf.

⁽²⁾ Manal Ismail is the Governmental Advisory Committee (GAC) liaison to the Board. The GAC liaison is not eligible for compensation.

The Chair of the Board is entitled (but not required) to receive compensation of \$75,000 or its equivalent annually, and other Board members (except the GAC liaison) are entitled (but not required) to receive compensation of \$45,000 or its equivalent annually. Upon request, compensation has been made to a legal entity owned by the Board member whose compensation therefore may not appear on ICANN's Form 990 (Part VII, Section A).
