## IANA Functions Operating Plan and Budget Structure

#### **IANA OP&B**

#### PTI OP&B

#### **Core IANA Services**

Delivery of the IANA services, including developing enhancements, reporting performance, and continuous improvement activities. Comprised of the naming, number and protocol parameter functions.

#### **Direct Dedicated**

Wholly dedicated employees and activities within PTI

e.g. Request Specialists, DevOps team, Audit, Continuous Improvement, Management

#### **Direct Shared**

Specific staff allocations from other ICANN depts

e.g. Key ceremony roles, dedicated IT operations and software developers, Finance, Board Operations, Legal

#### **Shared Services**

Communal services used by whole ICANN org

e.g. Ombudsman, Communications. Language Services, Human Resources, Travel Services, Procurement

#### **ICANN OP&B**

Non-IANA related costs

e.g. Root Zone Maintainer Agreement, IANA Function Review, **Customer Standing Committee** 

**Contract Oversight & Auxiliary Services** 

Costs incurred by ICANN to

oversee PTI's performance of

IANA services, plus costs solely

incurred to enable IANA functions

# **PTI FY21 Plans Development Status**

- The Draft FY21 IANA and PTI Operating Plan and Budget was developed from July through September 2019
- The six-week Public Comment started on the 14
   October and ends on the 27 November 2019

# **Draft FY21 IANA Functions Budget Summary**

## **IANA Functions Funding/ICANN Funding**

FY21 Funding of IANA Functions is \$10.6M provided solely from ICANN and is driven by the FY21 Expenses

2

## **IANA Functions baseline cash expenses**

FY21 Expenses of \$10.6M (including \$0.5M contingency) increased versus FY20 Forecast driven by inflationary Personnel increases of \$0.3M, partially offset by decreases in administrative activities of \$0.2M

### **IANA Functions contingency**

Contingency of \$0.5M remains flat in FY21 compared to FY20 Forecast.

Contingency is about 10% of the Direct Dedicated costs and represents an amount of budgeted expense unallocated to specific activities or departments



## **Capital Budget**

Capital for FY21 is for a Hardware Security Module (HSM) Replacements and Key Management Facility (KMF) improvements


