IV, § 2.16.) Article IV, Section 2.17 of the Bylaws state that the Board (or the NGPC) "shall issue its decision on the recommendation of the Board Governance Committee *within 60 days of receipt of the Reconsideration Request or as soon thereafter as feasible.*" (Bylaws, Art. IV, §2.17.) Requestors are regularly notified at each step of the proceedings, including whether there will be a delay beyond the suggested response deadlines, and whether the matter will be submitted to the NGPC and/or the Board.
