(Bylaws, Art. IV, § 2.16.) Article IV, Section 2.17 of the Bylaws state that the Board (or the NGPC) "shall issue its decision on the recommendation of the Board Governance Committee within 60 days of receipt of the Reconsideration Request or as soon thereafter as feasible." (Bylaws, Art. IV, §2.17.) Requestors are regularly notified at each step of the proceedings, including whether there will be a delay beyond the suggested response deadlines, and whether the matter will be submitted to the NGPC and/or the Board.
