#### **0.** Executive summary

As required by the Registry Agreement between the Internet Corporation for Assigned Names and Numbers (ICANN) and Fundació puntCAT (.cat Registry), this first report provides an overview of puntCAT activity for January 2010.

The information is primarily presented in table and chart format with explanations as deemed necessary. Information is provided in the order as set forth in Appendix 4 of the Registry Agreement.

#### 1. Accredited Registrar Status

Table 1 displays the current number and status of the ICANN accredited registrars on report's date.

The registrars are grouped into three categories:

- 1. *Operational registrars:* Those who have authorized access into the Sponsor's registry system for processing domain name registrations.
- 2. Registrars in the Ramp-up Period: Those who have received a password to access the puntCAT operational test and evaluation (OT&E) environment. The OT&E environment is provided to allow registrars to develop and test their systems with the puntCAT registry system.
- 3. Registrars in the Pre-Ramp-up Period: Those who have been sent information by puntCAT, but have not yet executed the Registry Confidentiality Agreement and/or have not yet submitted a completed Registrar Information Sheet.
