1. Accredited Registrar Status -

Table 1 displays the current number and status of the ICANN accredited registrars. The registrars are grouped into three categories:

Operational registrars: Those who have authorized access into the Sponsor's registry system for processing domain name registrations.

Registrars in the Ramp-up Period: Those who have received a password to access the dotCoop operational test and evaluation (OT&E) environment. The OT&E environment is provided to allow registrars to develop and test their systems with the dotCoop LLC registry system.

Registrars in the Pre-Ramp-up Period: Those who have been sent a welcome letter from dotCoop, but have not yet executed the Registry Confidentiality Agreement and/or have not yet submitted a completed Registrar Information Sheet. In most cases registrars are sent welcome letters via email on the same day accreditation notification is received from ICANN.

There were two unrelated incidents this month which resulted in unplanned outages. As the registry operator, we take any disruption to services very seriously, as the reports below show.

1. Detail: Up to 100% packet loss to/from and within Poptel networks.

Time and Date problem started: 9.16pm, Wednesday 13th November

Time and Date Problem Resolved: 1am, Thursday 14th November

Resolution: Diagnosed that a server was using a significant amount of bandwidth on the network, possible denial of service attack, bringing the network to a standstill. Disabled switch port, network resumed services immediately.

Prevention: Reviewing procedures to ensure that .coop services are not impacted in the future.

2. Detail: Standby firewall experienced power failure. Reboot didn't seem to work properly and had no IP addressing details on each interface. Active firewall incorrectly reconfigured itself to standby firewall during this, therefore none of the firewall's were forwarding packets through the firewall. All access from/to Poptel network from/to dial-in, internal and internet experiencing 100% packet loss. Possible power unit problem within firewall.

Time and Date problem started: 17:12, Wednesday 20th November 2002

Time and Date Problem Resolved: 17:37, Wednesday 20th November 2002

Resolution: Reboot of standby firewall restored full configuration, restoring active firewall to role.

Prevention: Firewall replaced 26/11/02.

3. gTLD Zone File Access Activity
