1. Accredited Registrar Status -

Table 1 displays the current number and status of the ICANN accredited registrars. The registrars are grouped into three categories:

Operational registrars: Those who have authorized access into the Sponsor's registry system for processing domain name registrations.

Registrars in the Ramp-up Period: Those who have received a password to access the dotCoop operational test and evaluation (OT&E) environment. The OT&E environment is provided to allow registrars to develop and test their systems with the dotCoop LLC registry system.

Registrars in the Pre-Ramp-up Period: Those who have been sent a welcome letter from dotCoop, but have not yet executed the Registry Confidentiality Agreement and/or have not yet submitted a completed Registrar Information Sheet. In most cases registrars are sent welcome letters via email on the same day accreditation notification is received from ICANN.

The .coop registry takes all unplanned outages very seriously and ensures both that they are fully investigated, and that measures are put in place to prevent a repeat.

Servers affected - tldalphaweb1 and 2 Date Time - 3 April 2003 15.30 GMT Affected - all web services

Reason:

This outage was the result of a DoS using the vulnerability that was found in WebDav on IIS only 2 weeks prior to the attack. In this instance, the patches had been applied to the evaluation servers, which were in the process of being tested before the live servers were patched. We feel that 2 weeks is an extremely quick turn round for a vulnerability being identified and our servers being affected, and that we have to weigh up the chance of patching early and introducing a bug against being hit by a DoS, therefore the only change we intend to make to our standard procedure is to shorten the time between patching the evaluation and live servers by tightening up our testing schedules.

3. gTLD Zone File Access Activity
