1. Accredited Registrar Status -

Operational registrars: Those who have authorized access into the Sponsor's registry system for processing domain name registrations.

Registrars in the Ramp-up Period: Those who have received a password to access the dotCoop operational test and evaluation (OT&E) environment. The OT&E environment is provided to allow registrars to develop and test their systems with the dotCoop LLC registry system.

Registrars in the Pre-Ramp-up Period: Those who have been sent information by dotCoop, but have not yet executed the Registry Confidentiality Agreement and/or have not yet submitted a completed Registrar Information Sheet.
