

## Letter of Motivation.



Expression of Interest as a volunteer for Competition, Consumer Trust and Consumer Choice Review Team.

I am responding to ICANN's recent call for volunteers for community members to serve on the Competition, Consumer Trust and Consumer Choice (CCT) Review Team, as a representative of the ccNSO.

Whilst I have previously served on the first Affirmation of Commitments (AOC) Accountability Transparency Review Team (ATRT I) as a representative of the ALAC, and my original work for ICANN within the IAG-CCT in 2010 - 2013 also as an ALAC appointed representative; for the ensuing Metrics WG resulting in the Board's resolution regarding the Collection of Metrics for the New gTLD Program to Support the future AoC Review on Competition, Consumer Trust and Consumer Choice, I served on behalf of the ccNSO in the Implementation WG, whose final report in 2014, has guided the data collection, that has resulted in the development of our new 'metrics hub' and it is as a continuing **representative of the ccNSO that I seek to be considered for serving on this upcoming CCT-RT**.

It should also be noted that I have a solid and extensive background on this topic as well as the AoC requirements for RTs and was a highly engaged participant in ATRT II as well as having followed closely, the work, processes and outcomes of the other AoC ICANN's Affirmation of Commitments; Thereby, I am confident that if selected to serve I will be fully prepared, effective and capable of carrying out the CCT-RTs mission to "examine the extent to which the introduction or expansion of gTLDs has promoted competition, consumer trust and consumer choice, as well as effectiveness of (a) the application and evaluation process, and (b) safeguards put in place to mitigate issues involved in the introduction or expansion."

Further as outlined in my online bio material (some online links listed below) much of my (extensive) volunteer work over the last 15-20 years has specifically focussed upon the interests of the Consumers and end users in the Telecommunications and Internet industry sectors.
