

ICANN Amendment No. 1 to .TEL Registry Agreement

Amendment No. 1 effective as of ("Amendment") to the Registry Agreement dated 30 May 2006 ("Agreement"), by and between the Internet Corporation for Assigned Names and Numbers, a not-for-profit California corporation ("ICANN"), and Telnic Limited, a private limited company incorporated in the United Kingdom ("Telnic"). Capitalized terms used but not defined herein shall have that meaning ascribed to them in the Agreement.
Whereas, on the ICANN Board of Directors adopted resolution 07 (insert link) and approved a proposed a contractual amendment from Telnic to enhance privacy for its customers under Appendix S, Part VII of the .TEL Registry Agreement and the Registry Services Evaluation Policy.
Whereas, at such meeting of the ICANN Board of Directors, the Board authorized the ICANN President and General Counsel to implement modifications to this Agreement as deemed necessary to provide for the proposed changes to the .TEL Whois specification.
Now, therefore, in consideration of the mutual agreements contained herein and intending to be legally bound hereby, the parties hereto amend the Agreement as follows:
1. After Appendix 1 B Section 3, Part r. append:
Its. disclosure-confirmed: disclosure of full information on this domain has been confirmed by the owner" and change the example domain container in Appendix 1 B Section 3 to: <pre></pre>
