 - 4. John reported on status of 802.1Q-Rev/D1.3.
 - 5. We discussed open issues on 802.1Q-Rev/D1.3. See Editor's Report.
 - 6. We noted that comments have been received from SC6:
 - a. Combined responses on IEEE 802.1Q-2014/Cor 1-2015, IEEE 802.1AB-2016, IEEE 802.1Qca-2015 and IEEE 802.1Qbv-2015. Due to time restrictions, we did not review these.
 - 7. Received liaisons:
 - a. We received and discussed a liaison from MEF in Interface Status TLV: http://www.ieee802.org/1/files/public/docs2017/liaison-MEF-L00261_InterfaceStatusTLV-0417.pdf. The conclusion was that 802.1 intended the meaning of the Interface Status TLV to be as described in the liaison. The earliest opportunity to generate such a liaison is at the July plenary.
