VEPAs are attached to external extended ports. The approach is to have the C-VLAN
component clear the E-CID from frames that it is reflecting back to ports that have a
VEPA attached. The VEPA will perform the echo-cancellation.

Qbg is ready to go to Working Group ballot. There was lots of discussion on how to get the reflective relay request and status parameters correct.

Status on original DCB projects is that they are all done with Sponsor balloting, but need Q-Rev and Qaz to complete. Qaz completed Sponsor ballot recirc without comment. However, Qaz included the entire LLDP MIB and this is being touched by Q-Rev – this may require another Qaz recirculation to sync-up the Q-Rev changes.

Pat reviewed the patent policy and made the call for patents. No responses occurred Pat provided a Qbb and Qaz status update. Editorial notes in Qbb and Qaz needs to be updated to indicated this depends on 802.1Q-2011. To be safe we need to ballot this change

Gu Yingjie presented a new work proposal. Migrate Dynamic information on Bridge while VMs migrate. Just a problem statement, no actions taken. Perhaps a proposal in July.
